A pre-bid meeting for procurement of Snow Removal Vehicles for Rescue 1122 Stations in Kumrat Valley District Dir Upper, Shogran Valley District Mansehra, Galiyat Valley (Thandiani & Ayubia) District Abbottabad, Kalash Valley District Chitral, and Gabin Jabba District Swat under PMU KITE DoT was held on November 09, 2021, at 1230 hours. - 2. Opening the discussion, the Procurement Expert PMU KITE DoT briefly explained to the forum that the instant procurement is carried out under the World Bank Procurement Regulations (Procurement in Investment Project Financing, Works, Non-Consulting and Consulting Services. July 2016 Revised November 2017 and August 2018) following Request for Bids (RFB) following International Market Approach.
- 3. The Standard Bidding Documents and Technical Specification of the instant procurement was explained/discussed in detail with the participants and the following clarification/ modification/ addition and deletion were agreed.
 - i. A new site (Gabin Jabba- District Swat) Tourist Rescue 1122 station has been added with the already advertised five (05) Tourist Rescue 1122 stations i.e Kumrat Valley District Dir Upper, Shogran Valley District Mansehra, Galiyat Valley (Thandiani & Ayubia) District Abbottabad, Kalash Valley District Chitral.
 - ii. The bidder's quote prices in any fully convertible currency in CIP including transportation cost from Karachi Port to the final destination of Tourist Rescue 1122 stations in Khyber Pakhtunkhwa.
 - iii. For evaluation purposes, the exchange rate for the conversion of the quoted currencies into a single currency will be December 7, 2021.
 - iv. The qualification criteria point A (2)(vi) shall now be read as "the bidders must provide two (02) years or 2,000 functioning hours warranty, whichever comes first.
 - v. The Working Width under Additional Attachments (Snow Blower) must be read as 2,000 or above.
